FOURTH DAY THURSDAY, JULY 20, 2017

The Convention was called to order at 10:00 a.m., President Loeb presiding.

Invocation: Sister Courtney Cunningham, Local 154.

GUEST SPEAKER

Spencer MacDonald, National Secretary, Broadcasting, Entertainment, Communications and Theatre Union from the U.K., addressed the delegation with the following salient points:

"So there are those that say unions are a thing of the past and the idea of solidarity, unity, and community are also a thing of the past. And how many times have you heard the words 'What's the union ever done for me?' or 'Who needs a union?'"

"Well-organized workers give members a stronger sense of confidence and the ability to change things, which we at BECTU started to do. People could be divided into three groups: Those who make things happen, those who watch things happen, and those who wonder what happened."

"So the next time someone asks me why should they join the union, the simple answer is, 'There is no limit to how bad things can get if you don't join a union."

AFTERNOON SESSION

The Convention was called to order at 2:35 p.m., President Loeb presiding.

Invocation: Sister Kedra Dawkins, Local 800.

GUEST SPEAKERS

Johannes Studinger, Head of UNI-MEI Global Union, addressed the delegation, outlining the following points:

"Since I addressed the IA Convention in 2013 in Boston, we've not stopped working with unions around the world to develop them to help to address issues and to build their capacity. Together, we represent 20 more unions in ten more countries in 2017 than in 2013. But more importantly, they represent more workers, and they do represent more collective bargaining coverage around the world that provide minimum pay standards, and protection for women and men working."

"An important part of the dues actually that you pay to us, gratefully, contribute to the Organizing Fund that we hold in place in UNI. This Organizing Fund helps to develop unions in developing countries, but also in countries in places where the right to organize, the right to be a member, and the right to be represented by a free trade union is not always guaranteed."

"Since 2013, during the last four years we have run projects organizing colleagues in the field in Brazil, Colombia, Ivory Coast, and Malaysia."

"In 2013, our World Executive Committee took the position to make Colombia a priority goal for organizing, and we put a substantive amount of resources and people to help courageous people in Colombia to organize in the broadcasting and the film sector... Through UNI-MEI, the brothers and sisters in Colombia realized that they are not alone. They found out that they are part of a global community that shares the same values and that is united in diversity."

"Of course, the financial means of the Organizing Fund that you and all other affiliates provide are important; and without these funds we could not do this work and have all these successes. But, more important, I think is your leadership, mentorship, and solidarity."

"The leadership of IATSE is critical to our work. It's critical for the success of union growth and our global work for freedom, dignity, and equality."

Hassan Yussuff, President, Canadian Labour Congress, addressed the delegation and made the following salient points:



"Eleven million workers go to work every day just like you and me. They're unfortunate they don't belong to our movement. Just because of that, the only pension they'll ever have is a public pension. We recognize we could do something to change that reality. We took on a campaign to say we will improve our public pension. It took us nine long years campaigning across the country, of course, educating our members as to why this is important because, likely, one day their kids are going to work in a workplace where they don't have a union. We want to ensure those kids are going to have a better pension when they retire."

"We've got to tell a different story. Because what we do every single day, we improve the laws that make working people's lives better in our country. We fight for social justice. We fight to make the society fairer. The public's got to hear more of what we do every single day. Where does that come from? It comes from all of us, including all of you in this great hall here today."

"While we have yet to achieve all the things we desire in our country, I can tell you without a doubt, we're quite determined to ensure we cannot only hold our density in our country, which has been at 29 and 30 percent for the last 30 years, we are determined. We just completed our CLC convention. One of the top priorities of our movement for the next three years is to grow that density beyond 30 percent in Canada."

"We've got to retell our story and we've got to take a responsibility. I keep saying we have three-and-a-half million members in the Canadian Labour Congress. If everyone tells the story, just think of how we would be perceived in society."

"Our movement is only strong if we're together, if we're united."
